## **What is misoprostol used for?**

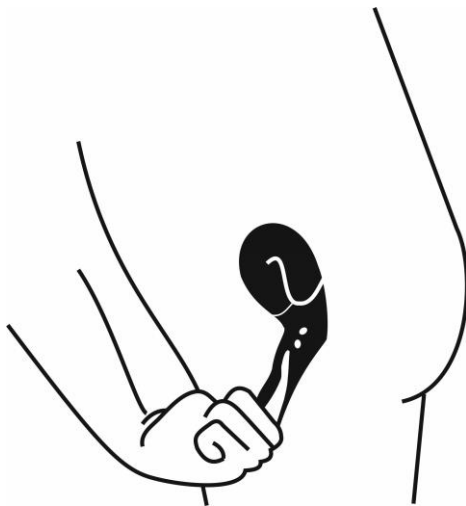
Misoprostol is used to open up the neck of the womb/uterus before inserting an intrauterine device (commonly called an IUD or contraceptive coil). It makes the coil insertion easier and may be helpful in women who have never had a baby or have experienced problems with coil insertion in the past.

## How is it used?

Misoprostol is an oral tablet which is usually used for the treatment of stomach ulcers. When used to dilate the cervix, it is inserted into the vagina.

The dose used is two tablets of 200 micrograms inserted high up in the posterior part of the vagina three hours before the appointment to have your IUD fitted.

1. Do a home pregnancy test to make 100 percent sure that you are not pregnant
2. Wash your hands
3. Remove the tablets from the foil wrapping
4. Lie down with your knees bent and legs apart
5. Gently insert two tablets into the posterior part of the vagina as high up as possible using your fingers
6. Remain in this position for 15 minutes to allow time for the tablets to be absorbed
7. Wash your hands



## **Are there any side effects?**

When misoprostol is inserted into the vagina the following side effects have been reported: feeling sick, lower abdominal pain or cramps, light vaginal bleeding, feeling of an increase in body temperature, fever and loose bowels. Usually, the side effects are mild and short lasting. But if severe, remove the tablets from the vagina and seek medical help.

Misoprostol tablets do not currently hold a product license for vaginal use before IUD insertion.

# What is product license?

A government department, the Medicine and Healthcare Products Regulatory Agency (MHRA), issues product licenses. In order to obtain a license, the manufacturer or importer of a medicine provides evidence to the MHRA to show that the medicine works for the illness to be treated, does not have too many side effects and is made to a high standard. Obtaining a license takes a long time and can be very expensive.

Although misoprostol tablets have a product license for treatment of stomach ulcers, the manufacturers have not yet applied for a license for their use prior to IUD insertion or for vaginal use. There are however reports in medical literature which show that vaginal misoprostol is safe and effective for dilating the neck of the womb prior to certain procedures such as: examination of the womb/uterus with a camera, inducing labour and termination of pregnancy and is hence widely used for these indications.

Clinicians may prescribe medicines that do not have a product license. Your clinician is aware that misoprostol tablets do not hold a product license for this use but feels that they may be of help to you.
